**Official Statement – IWWF Commitment to Para Wakeboard Development**

The International Waterski & Wakeboard Federation (IWWF) reaffirms its long-term commitment to the structured development and integration of the para cable wakeboard discipline, in line with the latest guidance and framework set forth by the International Paralympic Committee (IPC). IWWF is committed to looking for partners in creating a new classification system, which will reflect this objective.


In support of this objective, the IWWF has granted Wouter Terryn the mandate to engage on behalf of the IWWF, with relevant academic institutions and the IPC to advance research and development in para cable wakeboard.

This includes but is not limited to, the preparation and execution of a Delphi study, as agreed during recent internal discussions, to ensure that the discipline evolves according to best practices and evidence-based methodologies.

As part of this initiative, Lunar Cable Park (SPAIN) will actively support Wouter Terryn in his projects by serving as the designated sports facility for conducting research activities, field observations, and testing. The facility will also contribute to the development of practical recommendations regarding infrastructure adaptations and standardization of cable wake parks to support accessibility in para cable wakeboards.

The IWWF fully supports these efforts as part of its broader strategy to promote accessibility, inclusivity, and structured growth across all disciplines of the sport.
